Should my application be accepted, I agree to pay the balance within 30 days from notice of my acceptance and/or prior to commencement of any program or access to the Club's facilities offered through this Junior Tennis membership. In the event my application is not accepted, my Application Fee will be refunded in full. Additionally, I understand the Club has a no tipping policy and that alternatively, a service charge will be added to any food or beverage charge I may incur. If my Application is accepted, I agree to provide a credit card on file. *Please note payments, including membership fee, must be paid by check.*

Bay Club Junior Tennis Member 2021 Guidelines

Access, Use of Facilities and Restrictions:

- Facilities Access: Tennis, Golf House restaurant and Summer Shack

- Tennis Access:
 - Monday - Friday Unlimited
 - Saturday and Sunday Not before 11:00 am
 - Practice Facility Access: Ball Machine and backboard

- Age Restriction: 10 to 23

- Annual Dues: \$250 / \$200

- Guest Policy: Permitted on designated guest days as determined by the club, applicable fees will apply

- Clinic/Lesson Participation: Pay for scheduled appointments

- Tournament Participation: Junior Club Championship

- Number of Participants Limited to 15 in 2021

Additional Considerations:

- All new applicants may be required to attend a mandatory Meet and Greet and Rules and Etiquette workshop with the Professional Staff.

- A valid credit card must be kept on file and will be used for any unpaid food and beverage and tennis merchandise charges.
